Entries must be typed or printed clearly on an official CFA entry form, or sent online/fax/ no phone entries accepted. It is the responsibility of exhibitors to confirm online/fax entries with the entry clerk. Neither the clubs or the entry clerk will be responsible for entries lost due to transmission errors. It is the exhibitors responsibility to check entry confirmation and notify the entry clear of any errors. All entries except fax/online entries must be accompanied by full entry fee payment. Any entry showing evidence of fungus, fleas, earnites or contagious disease will be asked to leave the show hall. All claws of all entries must be clipped prior to benching. No declawed cats may be shown. Kittens for sale or entry must be four months of age. **Supplies** Litter will be provided. Please bring your own litter pans. Single cage size is 22° x 22" x 22". Please bring cage curtains, litter pan and rug. If this is your

first show, please let us know and we will bench you next to an experienced exhibitor.
