**Entries:** Make check payable to Platinum Coast Cat Fanciers, Inc. Payment at the door must be in cash and will incur a \$5 pay at the door fee. All online entries MUST be paid in full within 10 days of receipt or prior to the start of the show, whichever is first as per CFA Show Rule 11.08a.

**Show Hall:** ARABA TEMPLE, 2010 Hanson Street, Ft. Myers, FL 33901 Phone 239-334-4010. The show hall is air-conditioned and handicap accessible. No smoking will be allowed in the show hall. NO cats or kittens may be left in the show hall overnight. \*\* End of row free to handicapped exhibitors.

**Show Hotel:** No Official Show Hotel, but some local options are: Red Roof Inn Fort Myers, 13000 North Cleveland Ave. North Ft Myers, FL 33903 Phone: 239-656-4000 (5 miles from the show hall and has been recently renovated). LaQuinta Inn, 4850 S. Cleveland Avenue, Ft. Myers, FL 33907 Phone: 239-275-3300 (less than 2 ½ miles from the show hall). Both hotels have outdoor pools, and offer free breakfast, high speed Internet service and lots of other amenities. La Quinta Inn & Suites Fort Myers Airport 9521 Market Place Road Fort Myers, FL 33912 Phone 239-466-0012 offers a free shuttle to and from the airport.

**Exhibitors Flying In:** The closest airport (about 17 miles from the show hall) is Regional Southwest International Airport (RSW), Fort Myers, FL.

**Benching:** Check in will be from 7:30 to 9:30 a.m. **Judging will begin at 10:00 a.m. on Saturday** and 9:00 am Sunday. Advertised show hours will be 8:30 a.m. to 4:00 p.m. both days. No cats will be permitted to leave the show hall before the posted show hours without the consent of the show management. The Platinum Coast Cat Fanciers will take reasonable care of cats and property, but will not be held liable for loss of property, damage, or accidents to cats or to exhibitors.

**Awards:** This is a CFA licensed show. Rosettes & ribbons will be awarded in accordance with CFA Show Rules. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional awards. It is the responsibility of each owner to enter and verify that all information contained on the confirmation is correct. Entry fees must accompany entry forms. First entries will include a show catalog. The clubs reserve the right to substitute judges should it become necessary. Incomplete entry forms will be returned. No refunds or substitutions may be made after the closing date. No refunds will be given for failure to bench.

**CFA Show Rules:** A copy of the current CFA Show Rules may be obtained by sending \$5.00 to The Cat Fancier's Association, Inc., 1805 Atlantic Avenue, P.O. Box 1005, Manasquan, New Jersey 08736-1005.

**Supplies:** Litter will be provided. Please bring your own litter boxes, pet food, and dishes. Single cages measure approximately 22X22X22. Use of security cages requires purchase space for two cages. Exhibitors are responsible for material or cage curtains to cover the top, sides and bottom or your cage.

**Household Pets:** Any cats and kittens are welcome to compete in the Household Pet (HHP) category. All kittens must be at least 4 months of age and no declawed HHP's can be entered. Adults over the age of eight months must be neutered or spayed. Please use a carrier to bring your pets to the show and be sure to bring your supplies- HHP's will be judged in all rings. HHP Exhibitors contact Charlene Campbell for assistance or additional info.

**Health and Sales:** This is a non-vetted show. All cats, kittens, and household pet entries are expected to be free from fleas, fungus, ear mites, and any contagious diseases. All entries must be inoculated against feline distemper, feline rhinotracheitis, calici viruses, rabies, and be tested negative for feline leukemia before entry into the show hall. All claws must be clipped prior to benching. Declawed cats and kittens are not eligible for entry. No kittens under four (4) months of age will be permitted in the show hall. All cats and kittens for sale must have valid Florida Health Certificates as required by Florida Law. The Platinum Coast Cat Fanciers will not be responsible if this law is not followed.
