Entries: Closing Date is 1/11/09 or when 225 entries have been received, whichever ever comes first. Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Entry clerk will call COLLECT if any questions arise concerning your entry. Make checks payable to Poppy State Cat Club. Fees MUST accompany the entry form. Paid entries will be entered before Online/Fax entries. No refunds for failure to bench.

Hours: Check-In on Saturday 7:30 a.m. - 8:30 a.m. Advertised show hours 9:00 a.m. - 5:00 p.m.

Benching: All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager.

Cages: Single cages are 21" x 21" x 21" and are provided with each entry. Double cages are 21" x 45" x 21". If you wish a double cage for a single entry, you must pay the additional cage fee of \$20.00. Single entry with security cage requires a double space. No more than two (2) kittens or one (1) adult may be benched in a single cage. The bottom, top, and three (3) sides must be covered.

Show Hall: Dixon May Fairgrounds. 655 S. First Street, Dixon, CA. The Show Hall is Climate controlled (heated & water cooled) and handicapped accessible. This is a Non-Smoking facility. WE HAVE GOOD PEOPLE FOOD!

Show Hotel: Super 8 2500 Plaza Court, Dixon, CA. 707-678-3399.

Supplies: Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

Health: This is a non-vetted show. It is strongly advised that all cats/kitten entered or present be inoculated before entry by a licensed veterinarian against feline panleukopenia, rhinotracheitis, calici and rabies and strongly recommended that entries be tested and found negative for FeLV before entry. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. Exhibitors in violation will be told to leave the show hall.

General: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$5 from CFA, PO Box 1005, Manasquan, NJ 08736. All cats/kittens must have all claws clipped prior to benching. Declared cats are not eligible for competition. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens can be submitted at the show to the master clerk. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors.

Poppy State Cat Club reserves the right to substitute judges in case of illness or emergency.
