- **GENERAL:** This is a <u>CFA</u> Licensed show and all show rules will be strictly enforced. For a copy of these rules, write to CFA, 1805 Atlantic Ave., Manasquan, NJ 08736. All adult cats must be registered with CFA.
- **FEES:** 1<sup>st</sup> Entry \$50.00, 2<sup>nd</sup> Entry \$40.00, 3<sup>rd</sup> Entry \$30.00, 4-Pack \$140.00. Additional entries \$30.00/each, Grooming Space \$30.00, Extra ½ Cage \$25.00, End-of-Row \$25.00. FAX is \$5.00 per transmission (waived if entry fee received prior to show date). Returned Check Fee is \$50.00.
- **SHOW HOURS:** Check-in Sunday will be from 7:30 a.m. until 8:30 a.m. Judging will begin promptly at 9:00 a.m. Advertised show ending is 4:00 p.m.
- **SHOW HALL:** Gwinnett County Fairgrounds, 2405 Sugarloaf Parkway, Lawrenceville, GA 30045. Phone: 770-963-6522.
- HOTEL: La Quinta Inn Duluth, 2370 Stephens Center Dr., Duluth, GA 30096 678-957-0500. Rates are locked \$59/dbl to \$69/king if **Reserved Early** 2 weeks prior to show.
- **TRANSPORTATION:** The Club will <u>not</u> be able to provide for transportation. If you are flying into Hartsfield Airport, your BEST choice is to rent a car.
- **SCORING:** All Championship, Premiership cats and Kittens will be scored for CFA National and Regional awards. Registration numbers for Kittens must be printed or written in the catalog for scoring. Rosettes will be awarded and permanent flats will be used in accordance with CFA rules.
- **NON-VETTED SHOW:** All cats and kittens should be free from fleas, fungus, ear mites and other diseases. All entries should be inoculated against feline enteritis, rhinotracheitis, and calici viruses and should be tested for feline leukemia. Declawed cats are not eligible for entry. Both front and back claws should be clipped.
- **BENCHING:** Only one benching request will be honored. If an agent is designated, no benching request will be honored.
- **ENTRY INFORMATION:** Entries CLOSE April 25, 2011. Use of a security cage with an odd number of entries will require the purchase of a Double Cage. All fees and benching requests must accompany entries. No refund for failure to bench. No phone entries or post dated checks. Faxed and email entries should be confirmed with a phone call or email. It is each exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors. Faxed and email entries must be followed by a check within 10 days of the show, but no later than check-in per CFA show rule 11.08a. Entries paid at the door will be assessed a \$5 fee. Any fees not paid by midnight May 5 will be assessed a \$20 late fee. Returned check fee is \$50. Checks should be made payable to Rebel Rousers Cat Club.
- **HOUSEHOLD PETS:** Entry fee \$10, Double Cage \$5. All cats will be judged two times. Entries presented by a licensed rescue group that are available for adoption the fee is \$1.

- **SUPPLIES:** Cages are approximately 22"x22"x24". Litter will be provided. Bring your own littler pans, dishes, and cat food. People food will be available. Novice exhibitors should bring cage curtains and grooming supplies. Please bring your cat in a suitable carrier.
