The entry clerk will call collect if your entry is incomplete.

**BENCHING:** All benching requests must be made at time of entry. NO EXHIBITOR MAY CHANGE BENCHING ASSIGNMENTS WITHOUT PERMISSION OF SHOW MANAGER. Cage dimensions are approx. 21"X23"x21". This is a non-vetted show. NO SMOKING will be allowed in the show hall. NO CATS OR KITTENS MAY BE CONFINED TO CARRIERS EITHER DISPLAYED OR UNDER CAGES.
