ENTRY INFO: Limited to a total of 225, top-ten format. The entry clerk will call collect if your entry is incomplete. You will receive an email confirm indicating receipt of your online entry. IT IS THE EXHIBITOR'S RESPONSIBILITY to confirm online entries with the Entry Clerk. Online entries must be paid within 10 days of sending or start of show (whichever comes first).
