All entries should be inoculated against Feline Panleukopenia, Rhinotrachetitis, and Calici Virus and Rabies and tested for FeLV by a licensed vet. Cats should be free of mites, fleas, and fungus. CFA rules require your cat's front & back claws be clipped.

Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$7.00 from CFA, 260 Main St., Alliance, OH 44601.

Litter will be available. Please bring your own litter pan, water bowl and cat food. People food will be available. Cats may not be left in the show hall overnight. The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. No watchman will be provided during the hours the show is not open. Our show hall, is heated and air conditioned. Smoking is not permitted. Directions will be sent with confirmation.
