**AWARDS AND SCORING:** Rosettes will be awarded & permanent ribbons will be used in accordance with current CFA rules. All Championship, Premiership & Kittens (whose req.# appears in the catalog) will be scored for Regional and National Awards.

This is a CFA licensed show & CFA rules will be strictly enforced. Persons entering a CFA show agree to abide by CFA rules. Show rules are available from CFA, PO Box 1005, Manasquan, NJ 08737-1005 for a \$5 fee. In the event of an emergency, Space Coast Cat Club reserves the right to substitute judges not listed. No kitten under 4 months of age will be allowed in the show hall for any reason. The show hall has NO overnight security. Neither the Club nor the show hall will be held liable for any loss or damage to property, persons, or cats. Well behaved children ONLY!! There will be NO vet inspection; therefore, cats are expected to be free of fleas, fungus, ear mites, and any contagious diseases. All entries should be inoculated against feline enteritis, feline rhinotracheitis, calici viruses, and tested for feline leukemia virus. BOTH front and rear claws must be clipped prior to benching; failure to do so will subject entry to disqualification. The Show Committee reserves the right to remove any cat/kitten from the show hall if suspected of having any of the above until a licensed vet can pass on the health of the cat – at the owner/exhibitor's expense.

**SUPPLIES**: Litter will be provided – bring your own litter trays. Cages measure 22 X 22 X 22 – Exhibitors bringing their own security cage will be required to purchase a double cage.
