OWNER'S RESPONSIBILITY: *Please verify with the entry clerk that your entries were received.*

PAYMENT INFORMATION: **Please make checks payable to Great Lakes Great Maines.**

Post-dated checks will not be accepted. Full payment must accompany all mailed entries. Per Show Rule 11.08A, all online entries must be paid in full within ten (10) days of receipt or prior to the start of the show, whichever is first (cash, check or money orders accepted only). There is a \$50 fee for any returned checks. ***Payments not received within two weeks after the show date, will incur an additional \$50 late fee.***

ENTRIES: May not be withdrawn once entry clerk has entered the information

BENCHING REQUESTS: *At least one request per exhibitor is guaranteed, but efforts will be made to honor other requests to the best of our ability. Whenever possible, handicap requests will be benched at no extra charge to the exhibitor.*

SHOW HOURS: Check-in will be from 7:30 to 8:30 a.m. Advertised hours are 9 a.m. to 6 p.m.

TRANSPORTATION: *Exhibitors will need to be responsible for their own means of transportation.*

FOOD & SUPPLIES: *Food service will be at the show hall for exhibitors. Litter will be provided. Please bring your own litter pans and cat food.*

SCORING: *Entries in Championship and Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Adult entries without a registration or TRN number will not be included in the count.*

HEALTH: *It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry.*

MISCELLANEOUS: *Show management will take reasonable care of cats and carriers, but will not be responsible for damage or loss. The show hall is a NON-SMOKING facility with heating and air conditioning. Benching cage size is 22x22x22.*
