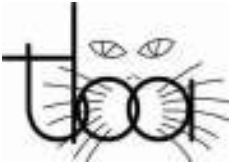

Please make all checks payable in US funds to **Tonkinese Breed Association**. All championship, premiership and registered kittens will be scored for CFA National and Regional awards. Telephone entries **WILL NOT** be accepted. Entry fees will not be refunded.

Benching will be from 7:30 AM to 8:30 AM with judging to begin at 9 AM sharp. All cats must be checked in by 8:30 AM or they will be marked absent. The advertised hours of the show are 9:00 AM to 5:00 PM Saturday and 9:00 AM to 4:00 PM Sunday. One benching request per exhibitor will be honored if possible. Handicap benching requests will be honored if possible.

No veterinarian inspection prior to benching is required. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested for FeLV before entry. All claws of all entries must be clipped prior to benching.

A detailed map to the show hall and hotel information will be sent with your confirmation. The show hall is climate controlled. This is a NON-SMOKING show hall. The cage size is 22" x 22" x 22". People food will be available. The show is handicap accessible. Litter will be provided but please bring your own litter pans and food. Tonkinese Breed Association members entry fee is \$35 per entry.
