Show Info

Entries: Email Entry Clerk to confirm receipt of online entries, the Club is not responsible for entries NOT received due to communication errors. No fax or phone entries. Per show rule 11.08 a.; Entries *must* be accompanied by all entry fees. Online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Midwest TGIF Fanciers. Send PayPal payments to tgifclub@swbell.net please note show and entry details. **Odd numbered entries with ANY size security cage must purchase a double cage space.** All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number.

RULES: It is advised that all entries be tested for FELV, and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus and Rabies before entry. Claws of all four feet must be clipped prior to benching. Cats may NOT be declawed. All cats must be free of fleas, fungus earmites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall of any of the above until a licensed veterinarian can make an examination at the exhibitor's expense. This show will be conducted under CFA rules. For a copy of the rules send \$7 to CFA 260 E. Main St. Alliance, OH 44601.

CAGES: A single (1/2) cage measures 21"x21"x 21", a full cage measures 21" x 21"x 42". Bring your own litter pans and food; litter will be provided.

SALES CAGES: You must have a CFA registered entry in the show to purchase a sales cage. Kittens must be at least four months old. CFA litter registrations will be required by show management. There is a maximum of two kittens or one cat per 1/2 cage. All sales animals must be in a cage. Positively no cats or kittens will be allowed in carriers under the tables.
