**ENTRY INFO:** *Entry fees include CFA surcharges.* It is the exhibitors' responsibility to confirm receipt of online entries with the Entry Clerk; the Entry Clerk and/or club will not be responsible for entries lost due to communication errors. All entry fees are due within 10 days of entry per CFA show rule 6.21. Make checks payable to TGIF, send PayPal payments to [tgifclub@swbell.net](mailto:tgifclub@swbell.net) No substitutions after the closing date. No refunds made once your entry is received or for failure to bench. *Single entries with security cages of ANY size require the purchase of an extra ½ cage.*

**SHOW HALL:** Purina Event Center, 300 Checkerboard Loop Gray Summit, MO 63039. Show hall is heated and air conditioned. Smoking is outside. Show hall is wheelchair accessible. **NO FOOD MAY BE BROUGHT INTO SHOW HALL.** Litter will be provided; bring your own litter pans.

**SHOW HOURS:** Check-in Saturday 9 -10:30 am. **Judging will start at 11 am on Saturday.** Show hours are 11 to end of final on Saturday and 9 am to end of finals on Sunday. **Note: The airport is 37 miles from show hall.**

**HEALTH:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

**SCORING:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601.

**BENCHING:** Cages are 22"W x 22"H x 22"D. One benching request made at the time of entry will be honored when possible.

**LIABILITY:** Midwest TGIF Fanciers will take reasonable care to safeguard the property of exhibitors. Neither the club, its members or Purina Farms will be liable for any loss or damage. No guard service will be available Saturday evening and all cats must be removed from the show hall during the evening hours.
