**THE SHOW HALL** is non-smoking and has central heating and cooling. People food will be available at the facility for purchase. Grand Parties are welcome.

**CHECK-IN HOURS** will be 8:30 am to 9:30 am. Any entry not checked in by 9:30 am will be marked absent. Judging will begin promptly at 10:00 am Saturday and 9:00 am Sunday. Show hours are 10:00 am Sat. and 9:00 am Sun until 5 p.m..

**HEALTH** This is a non-vetted show. Exhibitors are urged to have all cats and kittens inoculated against Calici Virus, Feline Enteritis, Rhinotracheitis and tested for FeLV. All cats must be free from infections, ear mites, fleas and contagious diseases. Claws must be clipped. All kittens must be four months of age on or before the first day of the show.

**ROSETTES** will be awarded in accordance with CFA Show Rules. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional points. For a copy of the current CFA Show Rules, send \$7.00 to the Cat Fanciers' Association, 260 East Main Street Alliance, OH 44601. The club reserves the right to add judges not named to judge non-championship and Household Pet classes.

**BENCHING REQUESTS** will be limited to one exhibitor and will be honored when possible. No negative benching requests please. End of row benching requests will be honored as available, with fee waived for disabled exhibitors.

**AMENITIES** Litter will be provided but please bring your own litter pans. It is also suggested that you bring your own food and water bowls. Cage size will be 36" x 24" x 27". One cat or two kittens may be benched per cage. People bringing their own double cages will need to buy additional groom space to accommodate the difference in cage sizes.

**NEW EXHIBITORS** should bring a towel or rug for the floor of the cage and enough fabric to go around and cover the top of the cage. ALL CATS MUST BE BROUGHT IN A CARRIER. Declawed cats are not eligible for entry.

**ENTRIES AND FEES** Make checks payable to Tonks West Cat Club. Each entry must be on a signed CFA entry form or exact facsimile. For entry clarification, the entry clerk will call collect. Entry fees must be received within 10 days of submitting an entry. Entry substitutions \$10 and returned check fees are \$35.
