All benched entries will be expected to remain in the show hall until advertised closing time, unless permission is given by Show Management

- 1) All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.
- 2) Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE. No refunds after the entry clerk has confirmed your entry or for failure to bench."  
"Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first
- 3) No veterinarian inspection prior to benching will be required. You are advised to have your cats inoculated against feline enteritis, Feline hinotracheitis/Pneumonitis, Calici Viruses, and tested negative FELV for entry. All cats must be free of fungus, ear mites, parasites, and all the above. The show committee reserves the right to remove any cat from the show hall until a licensed veterinarian can pass on all cats. All cats must have their nails clipped prior to benching.
- 4) According to CFA rules no declawed cats are shown. Reasonable care will be taken of cats and personal property. Neither Tornado Alley, Cats KC, nor their individual members shall be liable for property lost or damaged. Johnson County Fairgrounds will not be liable for any loss or damaged. *Smoking is outside. Show hall is heated no air condition Show hall is handicap accessible.*

SUPPLIES: Litter will be provided. Bring your own litter pans, cat food and water dishes. A single cage is provided with each entry. Single cage size is 21 x 21 x 21; double cage size is 21 x 21 x 45. Bring cage curtains or towels to hang on the inside, top and Bottom of cage.
