**Judging:** There will be 3 AB rings on Saturday and 3 AB rings on Sunday. HHPs will be shown in all 6 rings. 225 entry limit.

**Entry Fees:** Fees MUST accompany entry form. A \$1/entry fee will be sent to Central Office per show rules.

**Entries:** Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Entry clerk will call COLLECT if any questions arise concerning your entry. A \$50 check fee will be charged on all returned checks. NOTE: We will accept fax, on-line and email entries. Paid entries will be entered before fax, email, or online entries. **No refunds for failure to bench.**

**Hours:** Check-In on Saturday 7:30- 8:30. Advertised show hours for exhibitors are 9-5 Sat, and 9-4 Sunday. Advertised show hours Sat 9-4, Sun 9-3. Judging will begin 9 AM both days.

**Show Hall:** The St Lucie County Fairgrounds, Building A, 15601 West Midway Road, Ft. Pierce, FL 34945. This is a Non-Smoking facility. Parking is free for exhibitors and spectators. Auditorium phone 772-462-1517

**Show Hotel:** There is no designated show hotel. Pet Friendly hotels include Motel 6, 2500 Peters Rd, Fort Pierce 772-461-9937; Days Inn, 6651 Darter Ct., Ft. Pierce 772-466-4066; Holiday Inn Express \$25 pet fee, 7151 Okeechobee Rd., Ft. Pierce 772-464-5000; LaQuinta Inns & Suites (Newly opened), 2655 Parkway, Ft. Pierce 772-828-4199 (all 4 are located off Okeechobee Rd. between I-95 & the Turnpike).

**Supplies:** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

**Health:** This is a non-vetted show. Treasure Coast Cat Club strongly recommends testing for FeLV/FIV. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. Exhibitors in violation will be told to leave the show hall.

**General:** CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$5 from CFA, PO Box 1005, Manasquan, NJ 08736. All cats/kittens must have all claws clipped prior to benching. **Declawed cats are not eligible for competition.** All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens may be submitted at the show to the master clerk. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors when the confirmation is received.

**Benching:** All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. One benching request made at the time of entry will be honored whenever possible. Remember that this is a request, not a requirement.

**Directions:** From Turnpike: Take Fort Pierce Okeechobee Road (SR 70) exit number 152; go West (left) on Okeechobee Road for 6.6 miles, turn left onto Peacock Rd; go .5 miles to the exhibitor entrance. Unload at Building "A" and then park west of Building "C"

I-95 from North: Take Okeechobee Road (SR 70) exit # 129; go West on Okeechobee Road for 7.1 miles, turn left onto Peacock Rd; go .5 miles to the exhibitor entrance. Unload at Building "A" then park west of Building "C"

I-95 from South: Take Port St. Lucie Midway Road exit #126; go Northwest (left) on Midway Road for 5 miles until it dead ends into SR 70. Turn left and go .1 miles to Peacock Rd, turn left onto Peacock Rd; go .5 miles to the exhibitor entrance. Unload at Building "A" and then park west of Building C
