**ENTRIES:** Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Entry clerk will call COLLECT if any questions arise concerning your entry. A \$50 fee will be charged on all returned checks. We will accept fax, online and email entries. A \$5 (per exhibitor) additional charge will be assessed if payment is made at check in.

**HOURS:** Check-in on Saturday 7:30 am – 8:30 am. Advertised show hours are 9:30 am-4:00 pm. Judging will begin at 9:00 AM.

**SHOW HALL:** Indian River County Fairgrounds, 7955 58<sup>th</sup> Avenue, Vero Beach, FL 32967. The show hall is a non-smoking, air conditioned facility. Parking is free. (772) 589-9223.

**SHOW HOTEL:** Vero Beach Resort (formerly Travel Lodge) is a pet friendly hotel in Vero Beach located on S.R. 60 just East of I-95. (772) 562-9991. There is a \$25 pet fee.

**SUPPLIES:** Clay litter will be provided. Please bring your own litter pans, cat food and water/food dishes.

**HEALTH:** This is a non-vetted show. Treasure Coast Cat Club strongly recommends testing for FeLV/FIV. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. Exhibitors in violation will be required to leave the show hall.

**GENERAL:** CFA show rules will be strictly enforced. A copy of the rules may be obtained for \$7 from CFA 260 E. Main St. Alliance, OH 44601. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. All championship, premiership and registered kittens will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens can be submitted at the show to the master clerk. It is the exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors when the confirmation is received.

**BENCHING:** All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. No refunds for failure to bench. Cages measure 22"W x 22"H x 22"D. Benching requests made at the time of entry will be honored whenever possible. Remember that this is a request, not a requirement.

Treasure Coast Cat Club will take reasonable care to safeguard entries and property of exhibitors. However, neither the Club nor Indian River County Fairgrounds will be liable for any loss or damage.
