Payment Info: Please make checks payable to Triple Crown Cat Fanciers. Post-dated checks will not be accepted. Full payment must accompany all mailed entries. Per Show Rules 6.21 and 6.20, all online entries must be paid in full within ten (10) days of receipt or prior to the start of the show, whichever is first (cash, check or money orders accepted only), and the use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the form is considered to be your signature. No withdrawing entries once they're entered. There is a \$50 fee for any returned checks. Payments not received within two weeks after the show date, will incur an additional \$50 late fee.

Show Hours: Check-in is from 7:30 to 8:30 a.m. on Saturday, with judging beginning at 9 a.m. both days. Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry.
