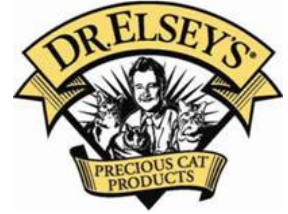

**Entry Info:** It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online or fax entries. The Entry Clerk or Club will not be responsible for entries lost due to communication errors. Fax/Email entries MUST be PAID within 10 DAYS of entry per CFA show rules. PayPal is accepted **until closing date only**, send PayPal to [meloncali@comcast.net](mailto:meloncali@comcast.net). Make checks payable to Tropical Cats. No substitutions accepted after the closing date. No refunds made once your entry is received. Only one agent or bench request per exhibitor. Phone entries and post dated checks are prohibited. Entries must be submitted on an official CFA entry form and all entries forms must be signed. CFA registration numbers must be included for all Championship and Premiership classes.

**Show Hall:** Townsend Pavilion, Volusia County Fairgrounds, 3150 E. New York Ave. Deland FL 32724 Phone 386-734-9515. The show hall is air-conditioned and handicap accessible. No smoking will be allowed in the show hall. People food will be available.

**Show Hotel:** Best Western Deltona Inn, 481 Deltona Blvd. Deltona, FL Show rate, \$59 + tax., call 386-860-3000 and mention the cat show for this special rate.

**Benching:** Check-in time will be from 7:30 am until 8:30 am, Judging will begin at 9:00 am. Advertised show hours are 10:00 am until 4:00 pm. No cats will be permitted to leave the show hall before the posted show hours without the permission of show management. Single cages will be 22" x 22" x 22". Please bring cage curtains, fabric or towels for the top, sides and bottom of your benching cage. *Use of ANY SIZE security cage with a single entry requires the purchase of an additional half cage space.* Litter will be provided. Please bring your own food bowls, water bowls, cat food and litter pans.

**Awards:** This is a CFA licensed show. Rosettes and ribbons will be awarded in accordance with CFA Show Rules. Permanent ribbons will be used for color classes. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional awards. It is the responsibility of each owner to enter and to verify that all information contained on the confirmation is correct. Entry fees must accompany entry forms. Incomplete entry forms will be returned. No refunds or substitutions may be made after the closing date. No refunds will be given for failure to bench. First entries will include a show catalog.

**Health & Sales:** This is a non-vetted show. Cats are expected to be free from fleas, fungus, ear mites and all contagious diseases. All entries must be inoculated against feline distemper, feline rhinotracheitis, calici viruses, rabies and be tested negative for feline leukemia before entry to the show hall. All claws must be clipped prior to benching. Declawed cats and kittens are not eligible for entry. No kittens under four (4) months of age will be permitted in the show hall. All cats and kittens for sale must have valid Florida Health Certificates as required by Florida Law. The sponsoring clubs will not be responsible if this law is not followed.
