ENTRY INFO: NO Additional Fees for Online/Fax Entries. Use of Security cages with an odd number of entries will require the purchase of an extra 1/2 Cage. Full payment must accompany all mailed entries. Per Show Rule 11.08a all fax or online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. **The \$5 Pay-at-the-Door Fee is per exhibitor and will be waived if fees are paid in full before check-in. Make checks payable to Tropical Cats Inc.** Send PayPal **BEFORE CLOSING DATE** to meloncali@comcast.net please note which show the payment is for. Email the Entry Clerk to confirm receipt of online/fax entries; neither the Entry Clerk nor the clubs will be responsible for entries lost due to communication errors. It is the responsibility of each owner to enter and to verify that all information contained on the confirmation is correct. No substitutions may be made after the closing date. No refunds will be given for failure to bench.

SHOW HALL: Townsend Pavilion @ Volusia County Fairgrounds 3150 E New York Ave (SR 44) DeLand, FL 32724. The show hall is air-conditioned and handicap accessible and non-smoking. People food will be available. Cats CANNOT be left in the show hall overnight. Cages are approximately 22x22x22 (1/2 cage). Litter will be provided. Bring your own litter pans, dishes and cat food. Please bring cage curtains and grooming supplies and transport your cat in a suitable carrier.

SHOW HOURS: Check-in: 7:30-8:30. Judging will begin at 9 am. Advertised show hours are: 10 am-4 pm. No cats permitted to leave show hall before posted show hours without permission of show management.

SHOW HOTEL: Travelodge Deltona (formerly Best Western Deltona Inn) 481 Deltona Blvd. Deltona, FL 32725 Ph: 386-860-3000. Tropical Cats has reserved a block of rooms at \$59.99 (plus tax). **There is another event at the hotel so MAKE YOUR RESERVATION ASAP.** See www.catshows.us/tropicalcats for other options.

LOCAL AIRPORTS: Daytona Beach Intl (DAB) is about ½ hour from the show hall and Orlando International (MCO) is about an hour from the show hall.

HOUSEHOLD PETS: Entries must be at least 4 months of age by 8/16/14 and may not be declawed; any entry over 8 months of age must be neutered/spayed.

AWARDS: All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules.

This is a CFA licensed show; show rules will be strictly enforced. Show rules are available at no cost online at www.cfa.org or send \$7 to CFA 260 E Main St Alliance OH 44601.

HEALTH & SALES: This is a non-vetted show. Cats are expected to be free from fleas, fungus, ear mites and all contagious diseases. All entries must be inoculated against feline distemper, feline rhinotracheitis, calici viruses, rabies and be tested negative for feline leukemia before entry to the show hall. All claws must be clipped prior to benching. Declawed cats and kittens are not eligible for entry. No kittens under four (4) months of age will be permitted in the show hall. All cats and kittens for sale must have valid Florida Health Certificates as required by Florida Law. The sponsoring club will not be responsible if this law is not followed.
