Make checks payable to TCCF (Twin City Cat Fanciers). Waive signature on overnight deliveries. A \$30 fee will be charged for returned checks.

All entries must be registered with CFA, except kittens and household pets. Kittens must be registered for CFA National and Regional scoring - registration numbers must be printed in the catalog or provided to the Master Clerk. All Championship, Premiership and registered Kittens will be CFA scored. No kitten under 4 months of age will be allowed in the show hall; exhibitors must have litter registration available to verify kitten's age. Only 2 cats or 4 kittens allowed per double sales cage. No kitten sales from the vending area. No cats allowed in show hall that are not entered or benched in sales cages.

Show hall is air conditioned, heated and is handicapped accessible. Handicapped benching requests will be accommodated, at no additional charge to the exhibitor. Free parking available. A map will be sent with confirmation.

**In accordance with Minnesota state statutes and CFA rules, there will be NO SMOKING in the show hall.**

There will be no veterinary inspection prior to benching. All cats must be free from fleas, ear mites or any infectious or contagious illness. You are advised to have your cat inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici virus and rabies and tested for feline leukemia virus before entry. Front and rear claws must be clipped prior to benching. No declawed cats may be entered. \*Show rule 2.19E The MISCELLANEOUS (Non-Competitive) CLASS is for any registered cat or registered kitten of a breed not accepted for Provisional Breed competition. Miscellaneous Class entries are examined by judges; however, no awards will be made in this class. All Bengal championship, premiership and kitten entries can enter under a TRN, but all Bengals in the show hall must be registerable, (5 generation pedigree with no wild blood). Parents are expected to supervise their children at all times! CFA SHOW RULES WILL BE IN EFFECT. Copies of CFA Show Rules may be obtained for \$5.00. Show Standard is free for individual breed or \$7.00 for complete set from CFA Central Office, 260 East Main Street, Alliance, OH 44601. These documents can also be downloaded from the CFA website. **SUPPLIES:** Litter will be furnished. Please bring your own litter pan. Bring your own cat food, food and water dishes.

**CAGES:** Approximate size is 21" x 21" x 21" (single cage, one-half of a double wire cage, included with entry). Second entry by same owner will be benched in the other half of a double cage, or the other half may be purchased for extra \$25 (noted as extra half cage), as available. Exhibitors using security cages must purchase extra half cage space if exhibiting one cat in the cage. Single security cage spaces are not available.

Bring your cat to the show hall in a carrier or other sturdy container. You will need drapes or towels to hang on the inside and cover the top and the bottom of the cage. Reasonable care will be taken of all cats and personal property, however, the show management is not responsible for anything lost or damaged.
