BENCHING INFORMATION:

Check-in: 8:00-9:30 AM Saturday. Judging begins promptly at 10:00 AM Saturday & 9:00 AM on Sunday. **Advertised show hours:** 10:00 to 4:00 both days. This is a non-vetted show. Cats must be free of fleas, fungus & infectious diseases. Cats showing any signs of illness or fleas will be asked to leave the show hall immediately. Cats should be vaccinated against feline enteritis, rhinotracheitis & calici, & tested for FeLV prior to entry. Vermont State law requires proof of rabies vaccination (bring certificates). Front & back claws must be clipped, no declawed entries allowed. **NO CATS/KITTENS TO BE LEFT IN SHOWHALL OVERNIGHT. SALE KITTENS MAY NOT BE HOUSED IN CRATES UNDER CAGES DURING THE SHOW. ALL SALE KITTENS MUST HAVE REQUIRED CAGE SPACE ACCORDING TO CFA RULES. NO KITTEN UNDER 4 MONTHS OF AGE ALLOWED IN THE SHOWHALL.** All Championship, Premiership & CFA registered kittens will be scored for CFA National & Regional wins. VFF reserves the right to add or change judges. Show rules available from CFA for \$5.00. Health & Rabies certificates required for sale cats/kittens (within 10 days). Show hall is heated and Handicap Accessible.
