This is a non-vetted show. All cats and kittens entered or present in the show hall should be inoculated against feline enteritis, feline rhinotracheitis, calici viruses, and rabies (required by Vermont state law - bring proof of vaccination), and tested negative for FeLV. All cats should be free from fleas, fungus, or other health problems. Any cat suspected of being ill, of having fleas, etc., is subject to removal from the show hall in accordance with CFA show rules. All claws must be clipped prior to benching

No cats/kittens to be left in show hall overnight. Sale kittens may not be housed in crates under cages during the show. All sale kittens must have required cage space according to CFA rules. No kitten under 4 months of age allowed in the show hall.

All Championship, Premiership & CFA registered kittens will be scored for CFA National & Regional wins. VFF reserves the right to add or change judges. Show rules available from CFA for \$5.00.

Health & Rabies certificates required for sale cats/kittens (within 10 days).

Show hall is heated and Handicap Accessible.
