ENTRIES: Properly completed must be submitted of an official CFA entry form or facsimile, faxed or sent online. The use of online entry form is interpreted as an official entry in this CFA show, and your email address on the online entry form is considered to be your signature per CFA show rule 4.05. If using the online entry please confirm receipt with the entry clerk, it is the exhibitor's responsibility to confirm entries, the entry clerk nor the club will be held accountable if entries are lost due to communication errors. No phone entries accepted. Each entry, except online entries must be accompanied by full entry fee. **NOTE: Faxed or other electronic entries are not guaranteed until payment is received.** All online entries must be paid in full in 10 days of receipt or prior to the start of the show, whichever is first. The club shall charge \$25 for entry fee non-payment beyond 10 day limit in CFA rule 11.08a. All check must be paid in US funds. **Make checks payable to Cats Incredible for Saturday's show and to Warwick Valley Feline Fanciers for Sunday's show. ALL Canadian entries must be paid in cash (US Funds) at the door (pay at the door fee will be waived for Canadian exhibitors).** Returned check fee is \$50 plus fees. Payments may be made using [PayPal](https://www.paypal.com) email payment to meloncali@comcast.net. **Anyone paying at check-in for ANY reason will be charged and additional \$5 pay-at-the-door fee.** Limit one (1) benching request per exhibitor. No refunds for failure to bench. *Sorry, no HHPs.*

SHOW HALL: The show hall is heated/air-conditioned, handicapped accessible and smoking is not permitted where cats are benched or judged. Show Management will take all reasonable care to safeguard the personal property of exhibitors. However, the clubs nor the hotel shall be liable for loss or damage to such property. All benched entries, with the exception of kittens, must remain in the show hall until the advertised closing hours of 5pm.

SUPPLIES & CAGES: Litter will be provided. Please bring cage curtains, fabric or towels to cover top, sides and back of cages. Food bowls, water bowls and litter pans will not be furnished. Single cage size is approximately 22"x22"x22". **Use of a security cage will require purchase of space equal to two single cages.**

EXHIBITOR INFORMATION: Cats Incredible, Inc. and Warwick Valley Feline Fanciers reserve the right to substitute judges in case of illness or emergency. Litter will be provided but no litter pans will be provided -- we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional Awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. Cats or Kittens should be clean and free of fungus, fleas, ear mites and any contagious of infectious illness. No kitten under the age of 4 months shall be permitted in the show hall. The state of New York mandates current rabies and inoculations for all cats -- it is advisable to bring your cat's certificate with you. All cats or kittens for sale must have entry in show and must ensure an enclosed, secured carrier. no exhibitor may leave cats or kittens in the show hall overnight. By entering all exhibitors agree to abide by the decisions of the judges and show committee and to adhere to CFA show rules.
