Entries properly completed must be submitted by exhibitors in the form of an official CFA entry form or facsimile, or an entry sent online (see link at website above) following such entry form with all information except signature typed or hand printed. The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the online entry form is considered to be your signature per CFA show rule 4.05. If faxing or using the online entry please confirm receipt. No phone entries accepted. Each entry, except faxes or online entries must be accompanied by full entry fee. All fax or online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Club shall charge \$25 for entry fee nonpayment beyond the 10-day limit in CFA show rule 11.08a. All checks must be paid in US funds. Limit one benching/agent request per exhibitor.

Benching: Entry check-in is at 7:00-8:00am on Saturday. Judging will begin at 9:00am. No change of benching assignments shall be made without permission of the show manager. All benched entries, with the exception of kittens, must remain in the show hall until the advertised closing hour of 5:00pm on Saturday. Cage size is approximately 22x22x22.

Show Hall is air-conditioned, handicapped accessible and smoking is not permitted where cats are benched or judged. People food will be available in the show hall. Absolutely no outside food or drink will be allowed in the show hall! Show management will take all reasonable care to safeguard the personal property of exhibitors. However, neither the club, its members, nor the hotel shall be liable for loss or damage to such property.

Exhibitor Information. William Penn Cat Club reserves the right to substitute judges in case of illness or emergency. Litter will be provided but no litter pans will be provided – we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. The state of New Jersey mandates current rabies inoculations for all cats – it is advisable to bring the cat's certificate with you. Cats or kittens should be clean and free of fungus, fleas, ear mites, and any contagious or infectious illnesses. No kitten under the age of 4 months shall be permitted in the show hall. All cats of kittens for sale or lease must be benched in the benching area, and must be eligible for CFA registration. The person offering the cat or kitten for sale must have an entry in the show and must ensure an enclosed, secured carrier. No exhibitor may leave cats or kittens in the show hall overnight. By entering all exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules.
