Entries: properly completed must be submitted by exhibitor in the form of an official CFA entry form or facsimile, or an entry sent online (www.catshows.us) following such entry with all information except signature typed or hand printed. The use of online entry form is interpreted as an official entry in this CFA show, and your e-mail address on the online entry form is considered to be your signature per CFA show rule 4.05. **If using the online entry please confirm receipt with the entry clerk.** No phone entries accepted. Each entry, except online entries must be accompanied by full entry fee. All online entry must be paid in full in the 10 day limit in CFA rule 11.08a. **All check must be paid in US funds and please make checks out to European Burmese Cat Club.** Limit one (1) benching request per exhibitor.

Benching entry check-in is at 9am - 10:30am on Saturday. Judging will begin promptly at 11am on Saturday and 10am on Sunday. No change of benching assignments shall be made without permission of either show managers. All benched entries, with the exception of kittens, must remain in the show hall until the advertised closing hours of 4pm. Cage size is approx. 22x22x22.

Show Hall: **The Wildwoods Convention Center - 4501 Boardwalk | Wildwood, NJ | (609)729-9000.** The show hall is air-conditioned, handicapped accessible and smoking is not permitted in the show hall. Show management will take all reasonable care to safeguard the personal property of exhibitors. However, neither the clubs, its members, nor the hotel/hall shall be liable for loss or damage to such property.

Exhibitor Information: William Penn CC & European Burmese CC reserve the right to substitute judges in case of illness or emergency. Litter will be provided but no litter pans will be provided -- we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National/Regional Awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. Cats or Kittens should be clean and free of fungus, fleas, ear mites, and any contagious or infectious illness. No kitten under the age of 4 months shall be permitted in the show hall. The state of New Jersey mandates current rabies and inoculations for all cats -- it is advisable to bring your cat's certificate with you. All cats or kittens for sale must have entry in show and must ensure an enclosed, secured carrier. No exhibitor may leave cats or kittens in the show hall overnight. By entering all exhibitors agree to abide by the decisions of the judges and show committee and to adhere to the CFA show rules. Copies of CFA show rules may be obtained for \$5 each from CFA, 1805 Atlantic Avenue, Manasquan, NJ 08736.
