**Entries:** *Entry fees include CFA/Regional surcharges.* It is the exhibitor's responsibility to confirm receipt of online/fax entries with the Entry Clerk; the club will not be responsible for entries lost due to communication errors. Mailed entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Fees MUST accompany the entry form. All entry fees are due within 10 days of entry per CFA show rules. Make checks payable to New England Meow Outfit or send PayPal to [nemocatclub@yahoo.com](mailto:nemocatclub@yahoo.com). No refunds for failure to bench. *Sales cage must accompany a paid entry. Use of ANY size security cage with odd numbered entries requires the purchase of an extra ½ cage space.*

**Hours:** Check-In: Saturday 9 – 10:30 am. **Judging will start at 11 am on Saturday** and at 9 am on Sunday. Advertised show hours are 11 am – 5 pm Saturday and 9 am – 4 pm on Sunday.

**Show Hall/Hotel:** [Sturbridge Host on Cedar Lake](#) 366 Main St. Sturbridge, MA 01566 Phone: 508-347-7393. \$92 single or double, \$102 triple, \$116 quad **if reserved by 9/20/2013**. There will be a one time non-refundable pet fee of \$25.00 for one night for all rooms that will have pets in them. Additional nights are \$10.00 per night. The Sturbridge Host is a three-star (AAA rating) hotel with restaurants, indoor pool and Jacuzzi, fitness center, and free Wi-Fi in all guest rooms. Contact the hotel directly for reservations; use code word NEMO for show rate. The show hall has AC/heat as needed. **No outside food/drink allowed in show hall.**

**Supplies:** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry.

**General:** CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens can be submitted at the show to the master clerk. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors.

**Benching:** All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. One benching request made at the time of entry will be honored when possible.
